- Completion of a vocational or occupational education sequence in child growth and development plus twelve months (1,820 hours) of verified experience in the care and supervision of four or more children under six years of age who are not related to the individual.
- Current certification as a Child Development Associate (CDA) or Certified Child Care Professional (CCP) or other Department-approved credential.
- Completion of a course of training approved by the Department that includes training and work experience with children in a child growth and development program plus twelve months (1,820 hours) of verified experience in the care and supervision of four or more children under six years of age who are not related to the individual.
- Twenty-four months (3,640 hours) of verified experience in the care and supervision of four or more children under six years of age who are not related to the individual plus either:
 - A current Colorado Level I credential
 - Two three-semester hour early childhood education college courses from a regionally accredited college or university, at either a two year, four year or graduate level, in each of the following subject or content areas with one course being either introduction to early childhood education or guidance strategies.
